All Employment Specialist trainings provided by HDC are provided in collaboration with Louisiana APSE and incorporate national APSE's Universal Employment First Competencies. The 40-hour core training includes three full days of classroom instruction and fieldwork assignments. It meets LRS/LWC and OCDD/Medicaid Community Rehabilitation Provider requirements.

The one-day Special Topic classes, also in collaboration with Louisiana APSE, can be used to meet Continuing Education requirements for LRS/LWC and OCDD/Medicaid Community Rehabilitation Providers and CESP renewal accreditation. The Louisiana state renewal requirement for staff of Community Rehabilitation Providers is 20 hours every three years.

All classes include training materials, presentation handouts, access to resources and a certificate of completion will be issued once identified course assignments have been completed and reviewed.

The HDC was established in 1974 as Louisiana's University Center of Excellence in Developmental Disabilities, one of a network of 67 UCEDDs across the country.

Our mission is to strengthen and increase the capacity of local communities to support and include individuals with developmental disabilities and their families in all aspects of life in the community.
